An asylum seeker is an individual outside of their home country who requests protection as a refugee in a new country, due to fear of being harmed or persecuted in their own country. Though the term refugees is used colloquially to describe someone who flees their country of origin, it is actually a legal label determined by national and international law.

The United States recognizes the right of asylum for individuals as specified by international and federal law. A specified number of legally defined refugees who either apply for asylum from inside the U.S. or apply for refugee status from outside the U.S., are admitted annually.

These officials should have a solid knowledge of refugee law. In most cases, the official will interview the asylum seeker to evaluate his or her evidence and credibility. The

burden is on the asylum seeker to prove that he or she meets the definition of a refugee and asylum seekers are encouraged to supply as much supporting evidence as possible. Supporting evidence may take the form of country reports, NGO reports, news articles, affidavits, or the in-person testimony of witnesses.
